2017 TRURO PRIDE PARADE DETAILS

Please join us on July 29th as we celebrate our diversity, our passion, and our pride. NHCS is requesting all participating groups to register in order to assist our Pride planning process.

Date: Saturday, July 29, 2017
Time: Start time 2:00PM (**Please be present between noon and 12:00 noon to set up**)
Start Point: Colchester Stadium on Lorne Street
End Point: Colchester East Hants Regional Library, Prince Street
Registration: **Pre-registration is required.**

Following the parade, there will be a celebration taking place on the green space in front of the Colchester East Hants Regional Library featuring music, food, vendors, community partners, etc.

Who needs to register?

Individuals and groups both need to register and sign waivers.

Rules and Guidelines.

- NHCS volunteers and staff are the onsite authorities. Any instructions given by them must be followed and your courtesy and cooperation is expected.
- Candies and other giveaways are **NOT TO BE THROWN** by any parade participant. This causes a serious safety hazard. Instead, please have people walking with your group to hand out these items.
- Floats are **permitted** in this year's parade. Be conscious of size, especially when dismantling your exhibit and parking your float vehicle.
- NHCS encourage groups who wish to march together to carry a banner or wear distinctive clothing to identify themselves as a group.
- Smoking is **not permitted** in the set up area or during the parade.
- NHCS reserves the right to screen all entries with an eye to overall impact on the parade, and its purpose.
- Dogs are permitted in the parade, they must be on a leash at all times and it is the owners responsibility to clean up after the dog.
- All entries **must be pre-registered** with NHCS office. Any group arriving unannounced on parade day may be refused.
- Registration fee is minimal - \$20.00 per entry (**This fee is only for recovering the cost of insurance, port-a-potties, etc**) **Please make cheque payable to NHCS.**
- All entries **must have the release waiver signed and submitted** to the NHCS in order to participate in the parade.
- Town, county and provincial laws and by-laws must be abided by at all times.

Exhibitors

As part of the celebration, NHCS is inviting community partners to set up display tables on the green space at the police station following the parade. Any interested community partners or exhibitors must complete and sign both the registration form and the waiver in this package. 2. Acknowledge that I fully understand that I will be engaging in activities that involve risk including but not limited to injury, death, and economic loss.
3. Assume any and all risks to myself, my group and or my/our property.
4. Agree to indemnify, defend, and hold harmless the Northern Healthy Connections Society (NHCS), the Town of Truro, Truro Police Service, their officers, agents, employees and volunteers , and all other participants from any and all claims, liabilities, losses and expenses caused by or arising in connection with the Truro Pride Parade.

Am aware that the Parade may be photographed, videotaped, or audio taped for publicity, historical, or educational purposes, and that the parade, including video, images and audio from it, may be shared in electronic form on the internet, or in print media, and understand that by participating in the Parade, that I (or my minor child) is likely to appear in materials resulting from the Parade.
